## **CAMP PHILOSOPHY**

---

Our goal is to provide each camper with the opportunity to:

- Participate in a safe and fun recreational indoor/outdoor environment that promotes both enjoyment and learning experiences for everyone.
- Make new friends, try something new, be creative and gain independence.
- Become more self- confident; use teamwork in a positive and effective manner.
- Develop a positive sense of self-respect and respect for property and equipment.
- Develop an appreciation of nature and enjoy being in the great outdoors.

## **PROGRAM CONTENT**

---

All camp programs have a balance of both quiet and active activities in indoor and outdoor environments. Weekly activities include: arts and crafts, organized sports and games, playground experiences, special events, board games, nature events, swimming at Centennial Beach (weather permitting), on-site entertainers and field trips. Field trips may be changed at any point in time during the camp.

## **CAMP STAFF**

---

All camps are supervised by the Program Manager, Camp Director, Assistant Director and 6-7 Camp Counselors. The Camp Directors have a college degree in education and are teaching in local school districts or surrounding area districts.

Assistant Director and Camp Counselors are all college-age staff. They provide a mixture of past staff with years of experience working in our camps and new, mature and enthusiastic individuals dedicated to making this a safe and enjoyable summer. All staff are CPR/AED and First Aid trained.

## **ARRIVAL AT CAMP**

---

If your child is attending summer school, when class has ended for the morning, your child's teacher will walk your child to the multi-purpose room or gym and sign them into camp.

If your child is not attending summer school, you will need to drop-off your child in the **multi-purpose room or gym and sign them into camp**. Drop-off begins promptly at noon! When dropping your child off for the day, you must sign your child in to camp. Please be on time so campers can eat their lunch and, for most days, be ready to board a school bus to attend afternoon activities.

**Beebe School please enter through door #4 of the school.**

**River Woods School please enter through door #13.**

## **DEPARTURE FROM CAMP**

---

When picking up your child for the day, you must sign them out every day. Campers must be signed out by a parent, guardian or authorized individual. A picture ID will be required from the people whose names are listed on the camper participation form; this is strictly for the safety of the child. If the person is not authorized to pick up your child, your child will not be allowed to leave camp with that person until we are able to contact you. Please enter through door #4 at Beebe and Door#13 at River Woods School. Pickup is held in the multi-purpose room or gym and begins at 4:30 p.m. and continues until 5:30 p.m. All children must be picked up by 5:30 p.m. at the latest. For the safety of your camper, we require that staff remain at the site until all children have been picked up. Please reciprocate by being on time for pickup. If you are running late, please call the Director of the camp. If a parent is continually late for pickup, the camper will not be allowed to continue to attend camp. There is an option for an early pickup at 3:45 p.m. each day except on Friday field trip days when campers will not return from field trips by 3:45 p.m. Pickup on Fridays is between 4:30-5:30 p.m. Please respect these times as it is very difficult for staff to coordinate activities and stay on schedule when these times are not adhered to. **For the safety of all campers, we are unable to accommodate pickup before 3:45 p.m.**

If you need to make contact with the Director during the camp day, please call the camp cell phone number for your camp location. If the camp staff does not answer the phone, please leave a voice mail. The Director will be checking voice mail frequently to retrieve messages.

## **ATTENDANCE**

---

If your child is sick or will be absent from camp, we would appreciate a phone call informing us of the absence. Please call the Director at your school location to report an absence.

## **LATE ARRIVALS**

---

For the safety of all campers, we discourage late arrivals. If you can't avoid a late arrival Monday-Wednesday, you must call the Camp Director and let them know. Campers **WILL NOT** be allowed to attend camp late on Thursday or Friday field trip days. On those days, you will need to make other arrangements for your child.

## **LUNCH**

---

The Park District will provide a lunch and a snack from Aramark for all Summer School Camp participants. Sample Lunch menu looks like the following:

- Fresh fruit or vegetable (apple slices, oranges, celery sticks, cucumber etc.)
- Bagged snack (Goldfish Crackers, pretzels etc.)

## **BUSING**

---

Most camps do travel, whether it is going to a park, a pool or on field trips.

- Busing for field trips is through First Student busing company.
- **For the safety of all campers, parents are not able to drop off or pick up at a field trip location (this includes Centennial Beach).**

## **STAFF TO PARTICIPANT RATIO**

---

The ratio of staff to participants is 1:10 when on-site at camp. When the participants travel off-site by school bus to Centennial Beach and the Friday Field Trips, the staff- to-participant ratio is between 1:6 and 1:8.

## **WHAT TO BRING TO CAMP (IN A BACKPACK)**

---

Water – Campers should bring a refillable water bottle to camp each day. Staff will administer routine water breaks to help ensure that all campers are remaining adequately hydrated throughout the day, especially on warmer days. Although campers are typically in areas that have immediate access to drinking fountains/water, there are times during the day (bus rides, hikes) when water may not be immediately available. Because of this, bringing a water bottle each day is essential to camper safety.

## **CAMP ATTIRE**

---

Campers should wear socks and gym shoes to camp every day. **For safety reasons, open toed shoes and bare feet are not allowed.** Unsafe or inappropriate footwear may limit your child's ability to participate in all of the day's planned activities. Campers play a variety of games and activities, please be sure to send them in clothes you don't mind getting dirty. On Friday Field Trip days, campers **MUST** wear their camp shirt.

## **SWIM ATTIRE**

---

Summer School campers will have scheduled swim days as well as possible water-related activities and field trips. Please send your camper with proper swim attire, a towel and spray sunscreen on those days.

## **SPRAY SUNSCREEN/BUG SPRAY**

---

All campers are required to supply their own spray bottle of sunscreen and/or bug spray due to allergic reactions. Please make sure to mark their name on the bottle. Parents should apply sunscreen prior to arrival at camp (especially on Thursday when going to the Beach and on Friday when the field trip is to a water park). For the protection of our campers, reapplication reminders by camp staff will occur throughout the day.

## **WHAT NOT TO BRING TO CAMP**

---

Please do not send the following items to camp with your children. If any camp staff member discovers them, the items will be given to the Camp Director for the remainder of the day.

- No electronic equipment (cell phones, iPods and game devices etc.).
- No personal possessions from home (toys, action figures, trading cards etc.).
- No sports equipment unless specified by camp staff.

These items are prohibited in the best interest of campers and staff as well as to lower the likelihood of the item being stolen, lost or broken. Not only are cell phones and other electronics expensive and can get stolen or lost, but also their usage can interfere with and even sabotage a child's overall experience at camp. **A camper that spends time immersed in technology does so at the expense of getting to know fellow campers and counselors.** Summer camp offers a great opportunity to learn about and navigate social situations while not being constantly connected to and immersed in a digital/virtual world.

## **CAMP ACTIVITY SCHEDULE**

---

Panel cards will be available at the parent meeting on May 31 and at camp. On the panel card will be the list of field trips, what to bring each day, the activity schedule for each day and the Camp Director's phone number as well as the Park District's phone number. Please put the Camp Director's phone number in your phone in case of an emergency or if you are running late for any reason.

The same activity schedule can be found below.

### **Monday and Tuesday**

Regular camp activities will be held on-site all day.

### **Wednesday Entertainment Days**

Each Wednesday camp will be visited by an entertainer or performer.

### **Thursday Swim Days and Friday Field Trips**

No official swim instruction is provided, but the lifeguards and camp counselors will supervise the campers while at the swimming locations. For the children wanting to swim in the deep end, they need to pass a deep water test conducted by the lifeguards at Centennial Beach or water parks. Participants also will be divided into groups with others of similar swimming ability while attending the Beach/water parks. On Thursdays, campers may bring money or parents can purchase a reloadable Park District gift card for purchase of concessions while attending Centennial Beach. Staff is not responsible for keeping track of the gift card. See the last page of this handbook for details on the Park District reloadable gift card.

Camp participants will travel on a wide variety of field trips. For safety reasons, children will receive a wristband to wear on field trip days. That wristband will have the cell number of the Camp Director's cell phone printed on it. Children can bring money to purchase more tokens on trips where that applies. Staff is not responsible for keeping track of cash. Money may NOT be brought on trips for the purpose of purchasing souvenirs. Please review the trip dates and destinations. ## **FIELD TRIPS RULES**

---

- Children will ride on a school bus to and from the field trips. All children attending camp that day will go on the trip. If you don't want your child going on the trip, your child **WILL NOT** be able to attend camp that day.
- For safety reasons, children will receive a wristband to wear on field trip days. That wristband will have the Camp Director's cell phone number printed on it.
- To ensure an enjoyable time, it is important that campers follow field trip rules. If a camper disobeys the rules, they will not be able to attend camp on field trip days.
  - Follow the Camp Code of Conduct including following the bus rules.
  - Stay with your group and group leader.
  - Always keep track of your partner.
  - Listen to your counselor.
  - Follow the rules of the destination we are visiting.
  - **Wear your summer camp shirt on the Friday field trips.**
  - **DO NOT TALK TO STRANGERS.**

## **ILLNESS**

---

**Children Must Be Fever Free for 24 Hours Before Returning to Camp.** If any child becomes ill:

- The parent/guardian will be notified by phone at once to pick up the child.
- If the parent/guardian cannot be reached, the emergency names listed will be contacted.
- If the child is well enough to attend/return to camp, they will be expected to participate with the rest of the campers

## **INJURIES**

---

While your child is at camp, the staff will administer first aid to any minor injury (bumps, bruises, cuts, scratches etc.). The parent/guardian will be informed of the injury at the time of pick up. If a serious injury occurs, the parent/guardian will be contacted by phone immediately and a staff person will remain with the child until the parent arrives.

For an injury or illness that requires emergency medical attention:

- 911 will be called and the child will be taken by ambulance to the nearest hospital for treatment.
- Parent/guardian will be contacted by phone immediately.
- If the parent/guardian cannot be reached, the emergency names listed will be contacted.
- A staff member will accompany the child in the ambulance and to the hospital.

## **HEALTH INFORMATION**

---

- Parents are required to fill out information regarding their child's health on the Participation Information Form upon registration for the program – allergies, medication and other safety and emergency information. The Participant Information Form can be found on the website under Camps. All information will be kept confidential.

## **WDSRA (WESTERN DU PAGE SPECIAL RECREATION ASSOCIATION)**

---

Any individual who registers for a Park District program and has a special need is eligible for inclusion services. The goal is to provide the least restrictive environment for an individual. Assistance varies depending on the needs of the individual and can range from adapting materials to sending support staff. There is no additional cost for participants to receive inclusion services. Reasonable accommodations are provided at no cost through WDSRA and the Park District. Participants pay only the regular program fees to the Park District.

## **MEDICATION**

---

Whenever possible, medications should be administered by parents or guardians prior to camp. If there is a need for the administration of medication during camp, medication will be administered by assigned staff only under the following conditions: the parent/guardian must:

1. Complete a Medication Dispensing procedure form. It must be signed by the parent/guardian before the medication can be administered. See your Camp Director for a Medication Dispensing form. This form also is located on our website at **[www.napervilleparks.org/camps](http://www.napervilleparks.org/camps)**. Look at Dispensing Medication Procedures and Form located under Summer School Camp.
2. The medication must be in its original container and not expired.
3. The label must bear the child's name, directions for administering the medication, dosage and doctor's name.
4. Non-prescription medication may not be given unless accompanied by a doctor's note.
5. All other medication is kept with the Camp Director in a locked container.

## **FOOD ALLERGIES AT CAMP**

---

Given the rise in childhood food allergies in recent years, the Naperville Park District is dedicated and committed to providing a safe environment for all children. Please note any severe food allergies on your child's Participant Information Form. If your child requires an auto-injector or inhaler while at camp, you must complete the Waiver and Release of All Claims for Use of Inhaler/Auto Injector. Please contact the Camp Director to discuss your child's personal needs. We will be happy to work with you to provide reasonable accommodations that will make your child's camp experience a safe one.

1. Inhalers should be kept with child at all times and can be administered by the child. Please make sure inhalers are properly labeled.
2. Severe allergy medications, such as an Epi Pen, will be kept with the child's camp counselor while they are at camp. Epi Pen must not be expired.

## **CAMP RULES/CAMP CODE OF CONDUCT**

---

In keeping with our program goals, we encourage fun for all of our participants. However, certain rules are necessary to ensure everyone's safety and enjoyment. **No refunds will be issued for suspensions or suspended days of camp.** Participants are expected to follow the following rules:

- Wear gym shoes every day to allow full participation in activities.
- Show respect for all participants and staff.
- No bullying, verbal or physical abuse, threatening, obscene, disrespectful or physical violence will be tolerated.
- Using abusive or foul language will not be tolerated.
- Threatening or causing bodily harm to self, other participants and/or staff will not be tolerated.
- Show respect for all equipment, supplies and facilities.
- **Do not bring ANY electronics, iPods, cell phones or hand-held games to camp.**
- Wearing clothing that depicts violence or inappropriate themes will not be tolerated.
- Refrain from bringing toys from home.
- Walk while indoors.
- Listen when staff gives instructions.
- Follow all directions given.
- Keep hands, mouth and feet to yourself. Do not place yourself or others in dangerous situations through actions or behavior.
- Theft or damage to NPD camp facilities or personal property is not tolerated.
- Do not leave the program area without permission. If a parent cannot be reached in this situation, the police may be contacted.
- Continuous disruption of the program is not tolerated.
- Lewd or obscene behavior is not tolerated.
- Pulling fire alarms or dialing 911 without cause is not tolerated.
- No weapons or items that may be used as weapons may be brought to the program.

## **BUS RULES**

---

- Remain seated while bus is moving.
- Keep hands, arms, legs and hair inside the bus at all times.
- Do not throw objects in or out of the bus.
- Be absolutely quiet when approaching railroad crossings.
- Assist in keeping the bus safe and sanitary at all times.
- Do not yell as it will distract the driver.
- Listen to the counselors at all times.
- Wait until the bus has stopped completely to get on or off.

Failure to follow the Naperville Park District Code of Conduct may result in removal of the participant from camp.

## **DISCIPLINE**

---

As with any large group of children, discipline must be reinforced by camp staff and the parents. We ask that you, as parents, please go over the camp rules with your child so they are aware of the consequences of poor behavior. When a child does not follow the behavior guidelines, the following steps will be taken:

### **1st Offense**

- Staff will redirect the child to more appropriate behavior.
- The child will be reminded of the behavior guidelines and rules and a discussion will take place. A verbal warning will be given. Depending on the severity of the offense, several warnings may be given.

### **2nd Offense**

- The staff will document the situation on a behavior or incident report.
- The staff will notify the parent about the situation at pickup.
- If the problem continues, a conference may occur with the parent, child, staff, Program Coordinator and Program Manager.

### **3rd Offense**

- The child may be suspended or expelled from our program if the offense persists. The suspension will be in effect immediately or the first day following the offense depending on the severity of the offense. The first time suspension will be for one day; the second time for up to three days. The parents will be notified by the Camp Director or the Program Manager. Upon return from a suspension, if behavior continues, the Program Manager may permanently suspend a participant from the Summer Camp Programs. In the event of a major offense, the ruling will be determined on a case-by-case basis.

## **DISMISSAL POLICY**

---

The Naperville Park District tries to meet the needs of each child enrolled in our program. We will make every effort to communicate and work with parents if there are concerns. However, the Naperville Park District reserves the right to terminate enrollment of any child. The decision to terminate child's enrollment may fall into different categories:

- If it is decided that the placement of a child is inappropriate and/or not in the best interest of the child.
- The Naperville Park District staff and the parent/guardian are not able to come to a mutually acceptable course of action after identifying and processing concern.
- A parent/guardian fails to meet their obligation.
- Any type of physical or verbal abuse of children, other parents or staff by the parent/guardian. Confrontation with other children at the program also is not acceptable.

We hope that by our staff communicating with the parents, it will deter any behavior that may be inappropriate. Every child is entitled to a safe, fun and pleasant environment at camp. We believe it is very important that parents take an active role in working with the staff to make the summer enjoyable for all campers
